## **TERMS AND CONDITIONS**

- 1. Information on how to participate forms part of these Terms and Conditions. Entry into this Promotion is acceptance of these Terms and Conditions.
- 2. Claims are only open to residents aged 18 years or over. Employees (and their immediate families) of the Promoter, Aussie Franchisees and agencies associated with this promotion are ineligible to claim. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.
