Colour in the Colouring-in Sheet and include all requested details as prompted on the sheet, including: I) their personal details (first name, last name, date of birth); II) name of their school; III) personal details of one of their parent's/legal guardian's (first name, last name, email, phone number); and 3. submit the fully completed Colouring In Sheet to the same Eligible Aussie Broker.													
Entries Permitted:	Only one (1) eligible entry per person will be accepted via each Eligible Aussie Broker. By completing the entry method, the entrant will receive one (1) entry.

1. The entrant agrees and acknowledges that they have read these Conditions of Entry (and Schedule) and that entry into the Promotion is deemed to be acceptance of these Conditions of Entry (and Schedule). Any capitalised terms used in these Conditions of Entry have the meaning given in the Schedule, unless stated otherwise.

Each entry will be judged on the basis of the individual creative merit of the completed Colouring Sheet submitted. The winners will receive the prize specified in the Schedule above.

If for any reason any aspect of this Promotion is not capable of running as planned, including by reason of computer virus, communications network failure, bugs, tampering, unauthorised intervention, fraud, technical failure or any cause beyond the control of the Promoter, the Promoter may in its sole discretion cancel, terminate, modify suspend the Promotion and invalidate any affected entries, or suspend or modify a prize, subject to State or Territory regulation.
